Manager's comments

- The sovereign debt crisis in the eurozone continued to dominate investor sentiment, although economic data from the US improved slightly.
- The strength of the US dollar and the weak global outlook resulted in poor performance by commodity-related companies.
- Sentiment in China remained negative with the A-share market continuing to slide.
- There are increasing signs that the Chinese economy is slowing with inflation dropping in November to 4.2% from 5.5% in October.
- This could give the government more room to fine tune economic policies.
- There was no significant transaction activity over the month.
- We remain concerned about a number of global issues, notably sovereign indebtedness in Europe, high leverage in the banking system, the fiscal situation in the US and the slowdown in China.
- On the positive side, many of these issues are now widely recognised.
- We believe that Chinese economic growth will slow in 2012.
- We continue to be cautiously positioned, preferring stocks exposed to consumption rather than investment.

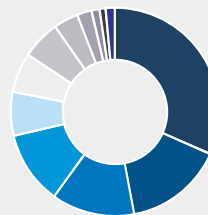

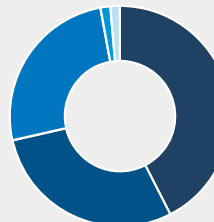
