Manager's comments

- Global listed infrastructure performed well this month as financial markets remained volatile and eurozone debt remained in the spotlight.
- The best performing sub-sector was Energy Infrastructure due to its stable cash flows and the announcement of several new projects.
- Water and Waste utilities lagged as the largest French water utility announced a significant asset divestiture programme in order to cut debt.
- By region, Latin America outperformed in light of increased M&A speculation among Brazilian distribution utilities.
- Europe was the weakest region (led by Germany) due to contagion fears of the sovereign debt crisis.
- Trading activity was limited over the month.
- We think 2012 will continue to be challenging as concerns over economic growth, inflation and political instability create further market volatility.
- Companies with solid balance sheets and strong governance will be best placed to navigate this uncertainty.
- We will continue to focus on quality infrastructure companies that can deliver inflation protected income and steady capital growth.

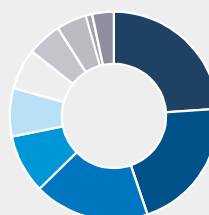

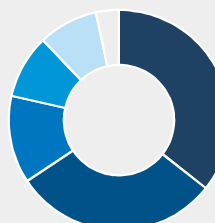
